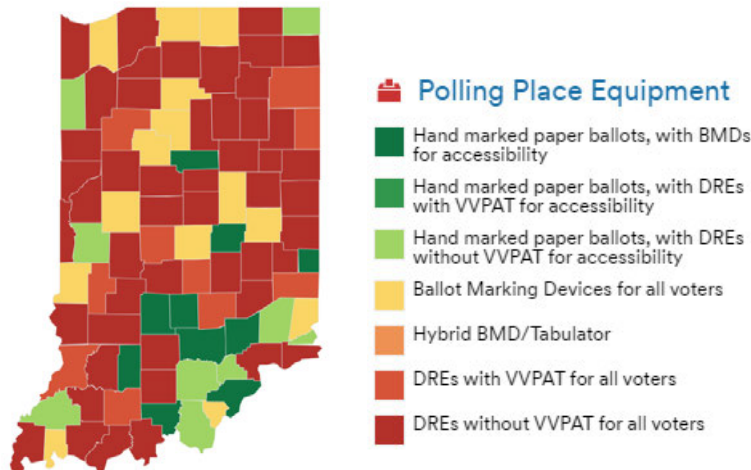


# “We the People” Petition Instructions

## Pathway to Certification

- ✓ The Process for Petition Certification requires that each petition have the individuals printed name, signature, physical address, and date.
  - It also requires verification that the individual signing is at least 18 years old and that they have received a copy of (or access to) the “We the People” petition language.
- ✓ Once more than 50% of the Total Population (18yrs and above) have signed the petition, all original signed petition documents will need to be filed with the Circuit Court Clerk(s) of your county.
- ✓ Circuit Court Clerks have 30 days to certify that all signers of the petition are residents in the county and area for which they have signed.
- ✓ The Clerk then makes a certification under their seal of office as to the number of signatures, the number of signed registered voters residing within the county, and the date of the filing of the petition within their office.
- ✓ The Clerk establishes a record of the filing within their office and files an original copy of the petition as well as their certification with the county governing body as well as the governing bodies mentioned within the petition language.
- ✓ The petition is an actionable document which requires the governing and assigned bodies within the petition to implement the requests brought forward.

## Timeline

- ✓ Within 24 hours of receipt of the “We the People” petition certification statement from the County Court Clerk, the Indiana Secretary of State’s office will remove the county voting data from the online tracking system and will issue a Decertification Statement to the Governor of Indiana that the petitioning county’s data has been removed pending a Full Forensic and Cyber Forensic Audit. An official recall certification statement will be made available to all Citizens within the State of Indiana.
- ✓ Within 24 hours of receipt of the recall and Decertification Statement from the Indiana Secretary of State’s office, Indiana’s members of the Electoral College will assemble in

the chamber of the House of Representatives in the State House and will sign a Decertification of Votes Cast Statement for the 2020 General Election. An original copy of this document will then be sent to the Office of the Vice President of the United States, to the National Archives, to the Chief Judge of the Southern District Court of Indiana (the federal courts), and to the Indiana Secretary of State's office.

- ✓ Within 24 hours of receipt of the "We the People" petition certification statement from the County Court Clerk, the Indiana National Guard will safely escort inactive representatives represented on the 2020 General Election ballot safely off public premises and shall secure each of their public office spaces pending the results of the Full Forensic and Cyber Forensic Audit and recertification.
- ✓ Within 24 hours of receipt of the "We the People" petition certification statement from the County Court Clerk, the County Council representing the county specified by the "We the People" petition will appropriate funding for the implementation of security systems (camera's, etc.) to be utilized in safe-guarding and 24 hour monitoring of all electronic matter and equipment in connection with and utilized in the 2020 General Election.
- ✓ Within 24 hours of receipt of the "We the People" petition certification statement from the County Court Clerk, the local Sherriff's department representing the county specified by the "We the People" petition will designate one deputy per each location within the county containing electronic matter and equipment in connection with and utilized in the 2020 General Election until 24 hour surveillance and security monitoring devices are in place.
- ✓ Within 72 hours of receipt of the "We the People" petition certification statement from the County Court Clerk, the local Sherriff's department representing the county specified, the County Commissioners representing the county specified, and the Indiana National Guard Active Duty Operational Support representing the county specified, shall hold a public meeting for the coordination and implementation of a Full Forensic and Cyber Forensic Audit completed by the Auditor of the People's choosing. Public meetings with the above representatives will continue through implementation and completion of the Full Forensic and Cyber Forensic Audits.
- ✓ The Government of the State of Indiana will maintain daily functioning duties under all remaining active representatives in conjunction with the Indiana National Guard and in coordination with all County Sheriff's departments.

#### Local Efforts

- ✓ Form a team in your local county and introduce them to the "We the People" Petition.
- ✓ Determine the total population of citizens (18 years old and above) within your county utilizing the 2020 US Census Data. Your county will require above 50% of residents as well as above 50% of registered voters to sign and file the "We the People" petition with your circuit court clerk.
- ✓ Identify a local address that can be used for county residents to return their signed petitions.
- ✓ Track the number of signatures received from both registered and non-registered voters.
- ✓ Two petition forms are available for signers. Single-signer petitions and petitions which can be utilized for the collection of multiple signers.
- ✓ All original signed paper petitions will need to be submitted to the circuit court clerk.
