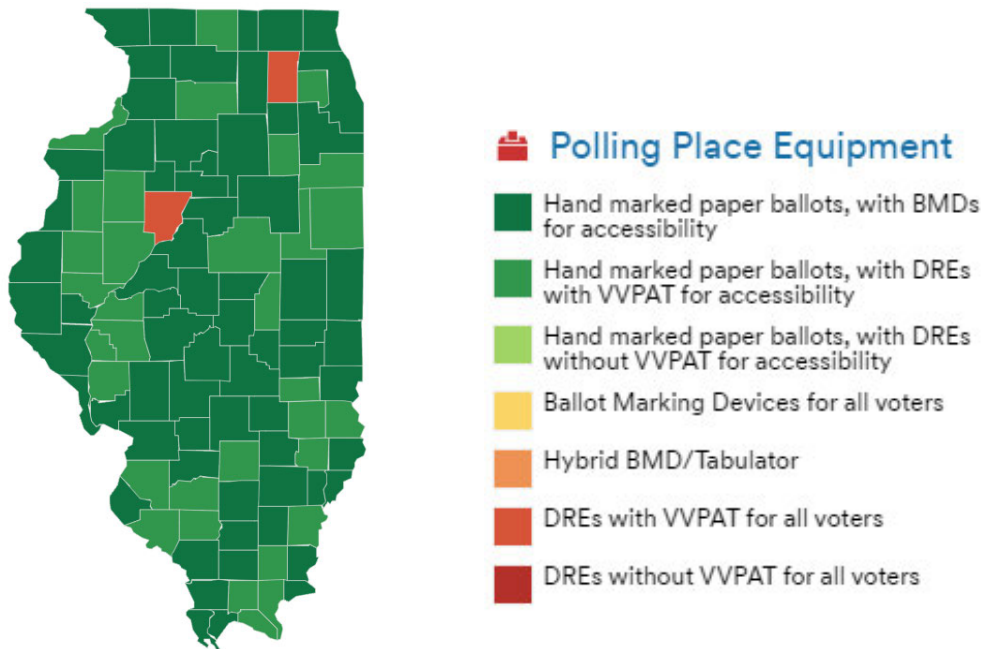

Every citizen’s vote is their property.

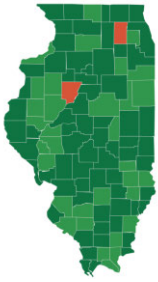
This petition addresses two issues, highlighted in Article 3, Section 3 of the Illinois State Constitution, which states that: “All elections shall be free and equal.”

An ‘equal’ election is one in which every citizen, in every county, has equal access to the same voting systems, equipment, and methods, and one in which the election is free of substantial errors.

A ‘free’ election is one which is absent interference and/or control.

In order to correct errors uncovered in the voting data from the 2020 General Election, this Petition decertifies the 2020 General Election until recertification based on a Full Forensic and Cyber Forensic Audit is complete in this county.

“We the People” Petition

Article 3, Section 3 of the Illinois State Constitution guarantees
all elections conducted in the State of Illinois,
“Shall be free and equal.”

An ‘equal’ election is one in which every citizen, in every county, has equal access to the same voting systems, equipment, and methods, and one in which the election is free of substantial errors. In Illinois, some counties have paper ballots, some have electronic equipment with paper ballot backup, and some have electronic equipment with no paper ballot backup. As a result, every citizen is not guaranteed that his or her individual vote will be counted, adjudicated, reviewable for accuracy, or will be capable of being audited in the same way—if it’s able to be audited at all. Without uniformity, transparency, and reviewability, a citizen cannot be guaranteed that his or her vote has been counted as intended. Moreover, the lack of reviewability impedes transparency and undermines confidence in the determinative ability of a citizen’s vote. The lack thereof rips apart the fabric which holds our nation together and destroys confidence in the voting process—a confidence which is necessary for a well-functioning republic. Because of the unequal application of standards, processes, accountability, and reviewability of votes cast, we the People of the State of Illinois, citizens of _____ County, cannot, and do not, consider the 2020 General Election to be “equal.”

A ‘free’ election is one which is absent interference and/or control. Given the unwillingness to provide a full forensic view of the entire election process, we the People of the State of Illinois, citizens of _____ County, cannot, and do not, consider the 2020 General Election to be “free.”

The usurpation of “free and equal” elections as guaranteed by the Illinois State Constitution, have unalterably infringed on the fundamental right of every Illinois citizen: the inherent right and power to ensure that the government reflects the will of its citizens through their vote and derives its authority solely from their consent and permission. Government is instituted for the benefit of its citizens; citizens don’t exist for the benefit of government.

Therefore, pursuant to power outlined in Article 1, Section 1, of the Constitution of the State of Illinois, to wit:

“All men are by nature free and independent and have certain inherent and inalienable rights among which are life, liberty and the pursuit of happiness. To secure these rights and the protection of property, governments are instituted among men, deriving their just powers from the consent of the governed.”

We, the People of the State of Illinois, citizens of _____ County, are hereby exercising our Constitutional right, per Article 1, Section 12, to “. . .obtain justice by law, freely, completely, and promptly” and do hereby Decertify the election results of the 2020 General Election. Recertification will begin pending the results of a Full Forensic and Cyber Forensic Audit completed by the organization of the People’s choosing.

As we the People of Illinois are the sole basis of your elected authority, we mandate our local County Council to immediately appropriate funding to initiate a Full Forensic and Cyber

Forensic Audit of all electronic equipment utilized in the 2020 General Election within _____ County, Illinois.

Effective immediately, the People of the State of Illinois, citizens of _____ County, accept the resignation of any elected or appointed official that denies the will of the People of Illinois, citizens of _____ County, in implementing the Decertification and Full Forensic and Cyber Forensic Audit. Nominations will begin for Special Elections to fill any vacancies.

As we the People of Illinois are the sole basis of your elected authority, we mandate our local _____ County Sherriff’s Department to secure all electronic matter and equipment in connection with and utilized in the 2020 General Election.

We, the People of the State of Illinois, citizens of _____ County, request that Adjutant General, Major Gen. Rich Neely and the Illinois National Guard, per their Oath to the Constitution of the State of Illinois ordained by the People of Illinois, and under “strict subordination to the civil power” per Article 12, Section 2, take immediate temporary control of the Government of the State of Illinois, and take the Lead role in implementing and coordinating the Full Forensic and Cyber Forensic Audit of the 2020 General Election, in coordination with People of Illinois, in _____ County, Illinois. Such power shall be temporary pending the results of the Full Forensic and Cyber Forensic Audit of the 2020 General Election. Control of the Governing Body will be maintained by the Illinois National Guard until results are released from the Full Forensic and Cyber Forensic Audits and election results are able to be re-certified for _____ County. The Government of the State of Illinois will maintain daily functioning duties under all remaining active representatives in conjunction with the Illinois National Guard and in coordination with all County Sheriff’s departments.

The Office of Secretary of State will immediately remove _____ County voting results from the 2020 General Election results.
