Your rights, per The South Carolina State Constitution, have been negated.

Every citizen’s vote is their property.

This petition addresses the following issues, highlighted in Article 1 Section 5, of the South Carolina State Constitution, which states that: “All elections shall be free and open . . .”

An ‘open’ election is one in which every citizen, in every county, has an unobstructed view of election results that are free of substantial errors.

A ‘free’ election is one which is absent interference and/or control.

In order to correct errors uncovered in the voting data from the 2020 General Election, this Petition decertifies the 2020 General Election until recertification based on a Full Forensic and Cyber Forensic Audit is complete in this county.

# “We the People” Petition

Article 1, Section 5 of the South Carolina State Constitution guarantees all elections conducted in the State of South Carolina:

**“ . . shall be free and open . . .”**

An ‘open’ election is one in which every citizen, in every county, has equal access to the same voting systems, equipment, and methods, and one in which the election is free of substantial errors. As a result of the unwillingness to conduct a Full Forensic and Cyber Forensic Audit, every citizen is not guaranteed that his or her individual vote will be counted, adjudicated, reviewable for accuracy, or will be capable of being audited in the same way—if it’s able to be audited at all. Without uniformity, transparency, and reviewability, a citizen cannot be guaranteed that his or her vote has been counted as intended. Moreover, the lack of reviewability impedes transparency and undermines confidence in the determinative ability of a citizen’s vote. The lack thereof rips apart the fabric which holds our nation together and destroys confidence in the voting process—a confidence which is necessary for a well-functioning republic. Because of the lack of transparency in processes, accountability, and reviewability of votes cast, we the People of the State of South Carolina, citizens of \_\_\_\_\_ County, cannot, and do not, consider the 2020 General Election to be “open.”

A ‘free’ election is one which is absent interference and/or control. Given the unwillingness to provide a full forensic view of the entire election process, we the People of the State of South Carolina, citizens of \_\_\_\_\_ County, cannot, and do not, consider the 2020 General Election to be “free.”

The usurpation of “free and open” elections, have unalterably infringed on the fundamental right of every South Carolina citizen: the inherent right and power to ensure that the government reflects the will of its citizens through their vote and derives its authority solely from their consent and permission. Government is instituted for the benefit of its citizens; citizens don’t exist for the benefit of government.

Therefore, pursuant to power outlined in Article 1, Section 1, of the Constitution of the State of South Carolina, to wit:

**“All political power is vested in and derived from the people only, therefore, they have the right at all times to modify their form of government.”**

We, the People of the State of South Carolina, citizens of \_\_\_\_\_ County, are hereby exercising our Constitutional right to, “. . at all times to modify” our government when necessary, and do hereby Decertify the election results of the 2020 General Election. Recertification will begin pending the results of a Full Forensic and Cyber Forensic Audit completed by the organization of the People’s choosing.

As we the People of South Carolina are the sole basis of your elected authority, we mandate our local County Council to immediately appropriate funding to initiate a Full Forensic and Cyber Forensic Audit of all electronic equipment utilized in the 2020 General Election within - \_\_\_\_\_ County, South Carolina.

Effective immediately, the People of the State of South Carolina, citizens of \_\_\_\_\_ County, accept the resignation of any elected or appointed official that denies the will of the People of South Carolina, citizens of \_\_\_\_\_ County, in implementing the Decertification and Full Forensic and Cyber Forensic Audit. Nominations will begin for Special Elections to fill any vacancies.

As we the People of South Carolina are the sole basis of your elected authority, we mandate our local \_\_\_\_\_ County Sherriff's Department to secure all electronic matter and equipment in connection with and utilized in the 2020 General Election.

We, the People of the State of South Carolina, citizens of \_\_\_\_\_ County, request that Adjutant General, Major General Van McCarty and the South Carolina National Guard, per their Oath to the Constitution of the State of South Carolina, established by the People of South Carolina and under "subordination to the civil authority" per Article 1, Section 20, take immediate temporary control of the Government of the State of South Carolina, and take the Lead role in implementing and coordinating the Full Forensic and Cyber Forensic Audit of the 2020 General Election, in coordination with People of South Carolina, in \_\_\_\_\_ County, South Carolina. Such power shall be temporary pending the results of the Full Forensic and Cyber Forensic Audit of the 2020 General Election. Control of the Governing Body will be maintained by the South Carolina National Guard until results are released from the Full Forensic and Cyber Forensic Audits and election results are able to be re-certified for - \_\_\_\_\_ County. The Government of the State of South Carolina will maintain daily functioning duties under all remaining active representatives in conjunction with the South Carolina National Guard and in coordination with all County Sheriff's departments.

The Office of Secretary of State will immediately remove \_\_\_\_\_ County voting results from the 2020 General Election results.
